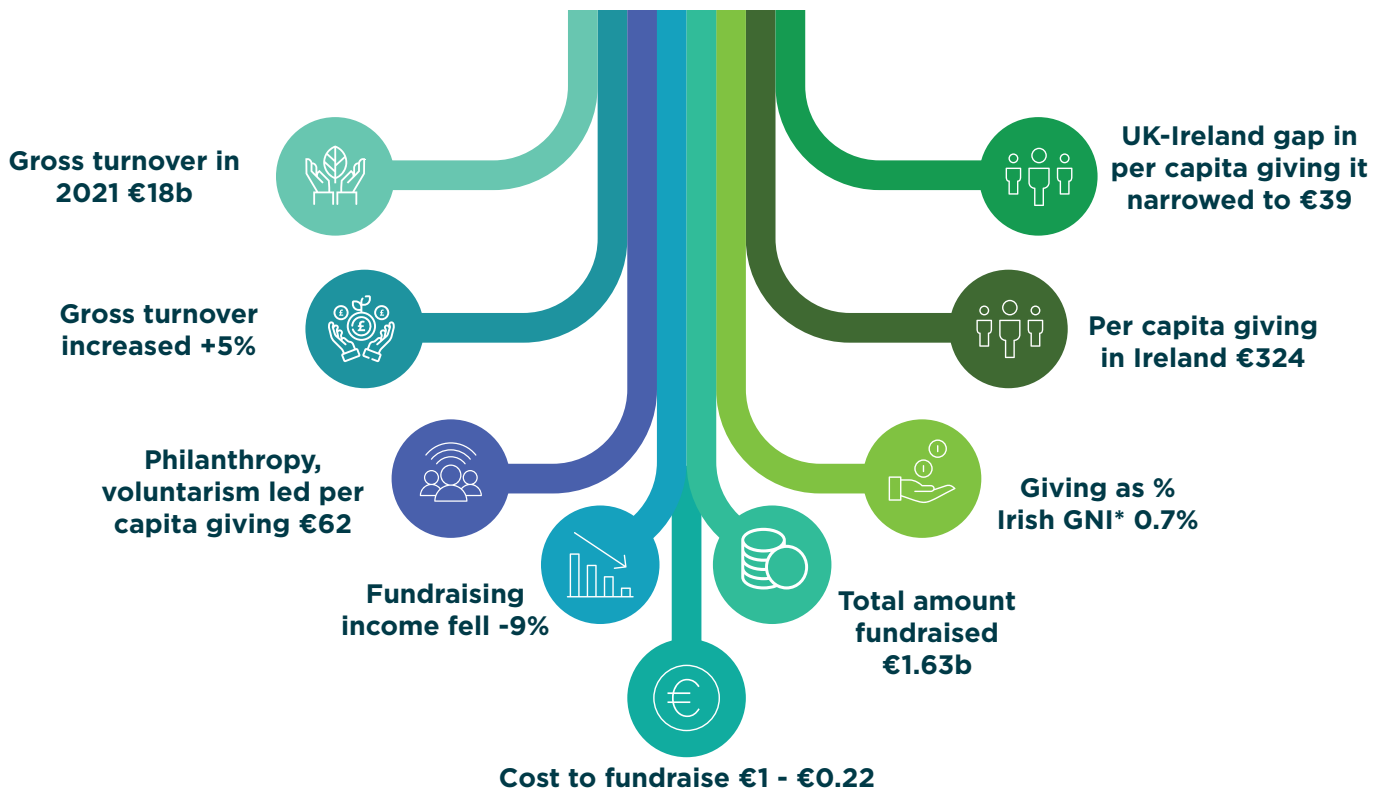


# Giving Ireland - Analysis and insights on funding report in partnership with Quilter Cheviot



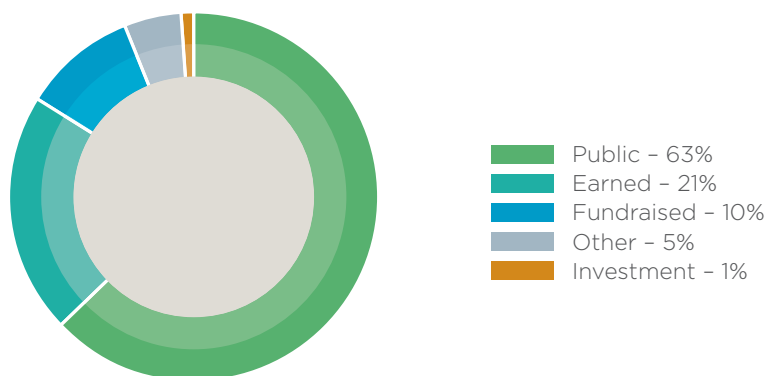

## Changes in income by source, 2020-2021

Source	Total	% Change 2020-2021	Difference
Gross	€18B	+ 5%	+ €810M
Public	€9.8B	+ 7%	+ €660M
Earned	€3.4B	+ 1%	+ €36.5M
Fundraised	€1.63B	- 9%	- €153M
Investment	€102M	+ 54%	+ €56M
Other	€702.5M	+ 4%	+ €24M

54% of the sector had an income of under €250,000 in 2021 compared to 21% with an income of over €1 million.

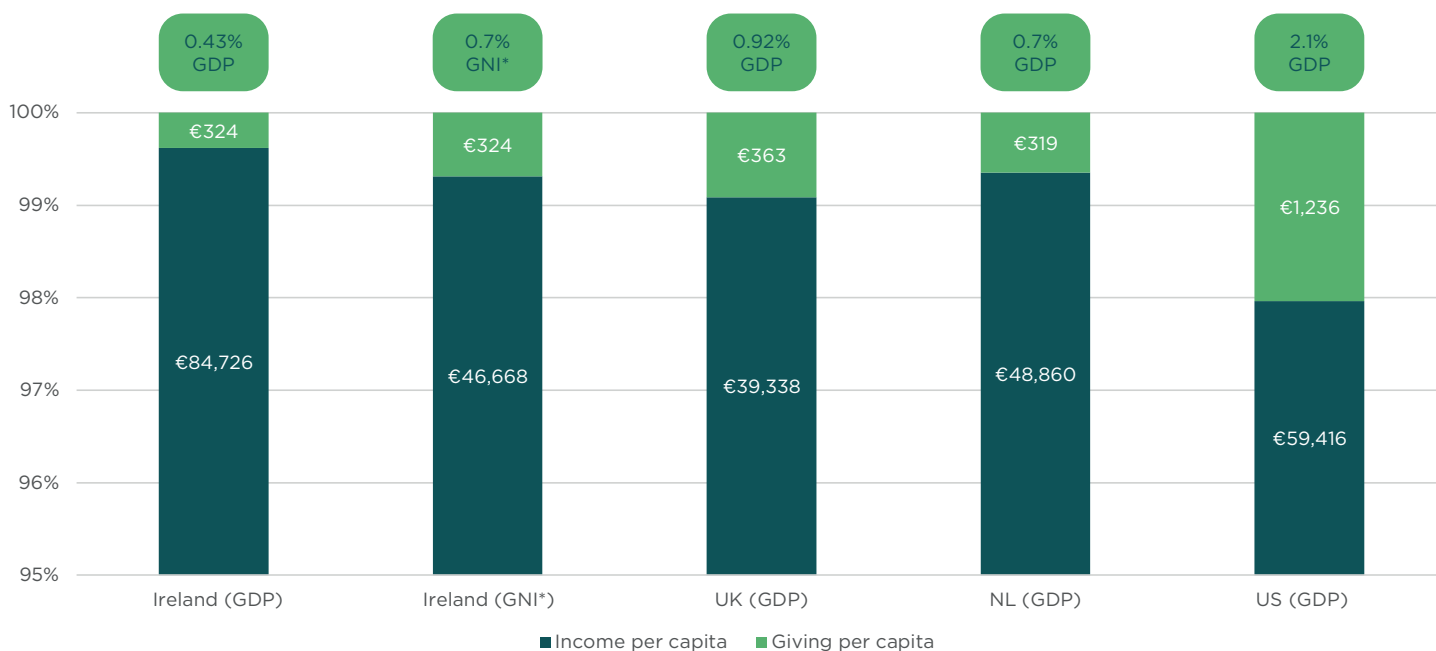
## Philanthropy and Voluntarism received the most fundraising (€62) per capita
